# GOOD NEIGHBOR PROGRAM

The University of Oregon strives to be a good neighbor. If you would like our help addressing a specific UO-related issue in your neighborhood, please email goodneighbor@uoregon.edu.

If you experience a loud party or other activity in a near campus neighborhood at which you expect UO students are involved and illegal activities are occurring, please Call the Eugene Police Department (EPD) non-emergency number (541-682-5111) to report the illegal behavior. Even if EPD does not have time to respond, this documents the incident and our office receives basic details, including time of call, whether EPD responded, and if so, what actions were taken. In certain situations EPD refers the call to the UO Police Department for response, even regarding off campus illegal behaviors in near campus neighborhoods.

# **NEXT GENERATION HOUSING**

As part of the UO's Next Generation Housing plan that meets the needs of a wide variety of students, the university is in the process of designing and building **two 800-bed residence halls** south of 17th Ave. between Columbia St. and Moon Lee Lane.

# Code Amendment, Refinement Plan Amendment, and Zone Change—as of October 28, 2025

In preparation for the Next Generation Housing Phase 2 residence hall, located south of 17th Ave. between Columbia and Moon Lee Lane and projected to be complete Summer 2027, the University of Oregon submitted a code amendment, refinement plan amendment, and zone change to the City of Eugene on March 21,2025. A code amendment and refinement plan amendment are necessary to build the Phase 2 residence hall.

The Planning Commission held a hearing on October 21. During the public verbal testimony, there were multiple requests to keep the record open for written submissions, and the motion to extend the open record time passed. The following are the key dates associated with the extension:

#### October 28, 2025, 5:00 p.m.

#### First Open Record Period, open to anyone

Deadline to submit written testimony (new evidence and argument) related to the approval criteria.

#### November 4, 2025, 5:00 p.m.

#### Second Open Record Period, open to anyone

Deadline to submit written testimony (evidence and argument) that directly responds to testimony received during the first open record period.

#### November 11, 2025, 5:00 p.m.

# Final Open Record Period, only for the applicant (the University of Oregon)

Deadline to submit written argument (no evidence) that directly responds to testimony received during the first and second open record periods.

# **CONSTRUCTION CORNER**

# UO Next Generation Housing Phase 1 Residence Hall

Construction of residence hall will be completed in time for occupancy fall 2027. (South of 17th Ave. between Columbia and Moss Streets)

Tower crane is in place. Current activities include excavation and installation of footings and columns, below ground utilities, concrete, and walls. Expect to see and hear forklifts, excavators, and trucks on and going to and from site.

Construction operation schedule for noisy activities is Monday–Friday, 9:00 a.m.–6:00 p.m.

Safety notice: We know it can be fun for all, young and old, to watch the big trucks and equipment at work. However, please keep in mind that visibility is often limited for truck and equipment operators. Please enjoy the view from a safe distance; watching from across the street can be a great way to stay safe while still enjoying the action. For a construction map, including entrances to the site where watching from a safe distance is especially important, click here.

#### **TEMPORARY ROAD CLOSURES**

Between January and June 2026 there will be temporary road closures for utility improvements 1) in 17th Ave. between Agate St. and Moss St. and 2) in Columbia St. south of 17th Ave. Timelines are subject to change due to material delivery dates, efforts to mitigate traffic impacts, weather conditions, and completion of the proceeding phase on time.

# Intersection Columbia St. and E. 17th Ave. (Jan/Feb):

When possible, local traffic will still be able to use 17th Ave., at times limited to one lane with flaggers assisting. Truck routes to the Central Kitchen are continuously reviewed to minimize disruptions and limit traffic impacts. Access to Columbia Street off 17th Ave. will most frequently be available from Agate St.

# Columbia St. South of E. 17th (Jan/Feb)

Utilities will primarily be installed in the east side of the street, allowing for one-way local access traffic only with the support of flaggers. Connections to the utility vaults in the street, both at the intersection and outside the central kitchen, will allow for detoured local access but limit through traffic at times.

#### 17th Ave. (March/June)

Installation of the remainder of utilities will occur in E. 17th Ave. to a connection point near Hayward field across Agate St.

Work will happen in multiple phases so that construction will never fully close Agate St. or eliminate local traffic access.

This will complete the major utility infrastructure work that will necessitate temporary road closures for the project. Clarifications on areas and timeline for each phase will be included in future updates.

#### **Knight Campus Building 2**

Riverfront Parkway and Millrace Dr. Exterior hardscapes, and planters are underway for landscaping. Interior finishes are underway on all levels, preparing for furniture deliveries. Building system startups and testing continue. The pedestrian boardwalk north of building 1 parallel to the Millrace will reopen early November.

Riverfront Parkway from Franklin Blvd. to Millrace Dr. will be closed October 27 through November 7 for reconstruction of roadway. East sidewalk will remain open.

Completion is on scheduled for March 2026.

# Demolition of Hamilton residence hall complex and creation of green space and UO women's beach volleyball facilities

Corner of E. 13th Ave. and Agate St.

The abatement phase continues.
Crews are removing and safely
disposing of hazardous materials
ahead of demolition. Hard
demolition, the actual breaking
down and removal of the building,
will begin in the first half of
November on north/13th Avenue
side of Hamilton while abatement
continues on the south side through
November.

When hard demolition commences, dump truck traffic will increase along 13th Avenue and the sidewalk on the south side of 13th Avenue will be closed to pedestrians from Agate Street east to the entrance to the Ford Alumni Center parking area. Vehicular access to Ford Alumni Center will remain open.
